In accordance with Section 153.54 et seq. of the Ohio Revised Code, each bid must be accompanied by a certified check on a solvent bank, cashier's check or irrevocable letter of credit in an amount equal to ten percent (10%) of the bid, or an acceptable bid bond equal to one hundred percent (100%) of the bid.

Bids are to be sealed and addressed to: Butler County Commissioners, 315 High Street, Hamilton, Ohio 45011. Bidders are required to use the Bid Forms and Envelopes furnished by the Butler County Engineer's Office.

Butler County Commissioners reserve the right to reject any or all bids. Bidders must be pre-qualified with the Ohio Department of Transportation for the type of work being performed.
