Notification of Headgates Road Closing

The Butler County Engineer's Office wishes to inform you that Headgates Road will close ten feet north of Ohio 4 and 900 feet south of Old Line Lane for a culvert replacement and drainage improvements beginning Monday, October 8, 2018. The road is tentatively scheduled to reopen the week of October 22, 2018, weather permitting.

The Project

This project is necessary to replace a culvert in an effort to facilitate improved drainage and water flow. Adjacent ditchlines will also be piped and catch basins installed. All work is being performed by crews from the Butler County Engineer's Office and funding for the project consists of 100 percent local BCEO Force Account funds.

Detour and Maintenance of Traffic

During this closure, local access to Headgates Road will be maintained for residents and businesses from the north side of the culvert, but motorists will not be permitted to pass across the culvert or enter the construction zone. Detours will be posted for all thru traffic.

Northbound Headgates Road traffic will detour southwest on Ohio 4, north on Campbell Drive, and northeast on Canal Road to Headgates. Southbound traffic will reverse this route.

Please note that all dates are approximate and may vary due to weather and other factors out of our control which can affect the schedule. Emergency personnel, school bus transportation officials, the post office, and the media have been notified of this upcoming closure.
