Notification of LeSourdsville West Chester Road Closing

The Butler County Engineer's Office wishes to inform you that LeSourdsville West Chester Road will close 0.5 mile north of Millikin Road and 0.4 mile south of Kyles Station Road for a culvert replacement beginning Monday, May 22, 2017. The road is tentatively scheduled to reopen the week of June 5, 2017, weather permitting.

The Project

This project is necessary to replace an aging and deteriorating culvert in an effort to prevent potential future structural failure and maintain proper drainage and water flow. All work is being performed by crews from the Butler County Engineer's Office with funding for materials provided by Liberty Township.

Detour and Maintenance of Traffic

During this closure, local access to LeSourdsville West Chester Road will be maintained for residents and businesses from either side of the culvert, but motorists will not be permitted to pass across the culvert or enter the construction zone. Detours will be posted for all thru traffic.

Northbound LeSourdsville West Chester Road traffic will detour west on Millikin Road, north on Ohio 747, and east on Kyles Station Road to LeSourdsville West Chester. Southbound traffic will reverse this route.

Please note that all dates are approximate and may vary due to weather and other factors out of our control which can affect the schedule. The best way for local motorists to stay informed is to check the Road Closings page on the BCEO web site at www.bceo.org/roadclosings. Emergency personnel, school bus transportation officials, the post office, and the media have been notified of this upcoming closure.
