Notification of Oxford Milford Road Closing

The Butler County Engineer's Office wishes to inform you that Oxford Milford Road will close 400 feet north of Ohio 73 and 0.9 mile south of Harris Road for a culvert replacement beginning Monday, June 11, 2018. The road is tentatively scheduled to reopen the week of June 25, 2018, weather permitting.

The Project

This project is necessary to replace an aging and deteriorating culvert in an effort to prevent potential future structural failure and maintain proper drainage and water flow. All work is being performed by crews from the Butler County Engineer's Office while funding for materials is provided by the City of Oxford.

Detour and Maintenance of Traffic

During this closure, local access to Oxford Milford Road will be maintained for residents and businesses from either side of the culvert, but motorists will not be permitted to pass across the culvert or enter the construction zone. Detours will be posted for all thru traffic.

Northbound Oxford Milford Road traffic will detour east on Ohio 73, north on Ohio 177, and west on Harris Road to Oxford Milford. Southbound traffic will reverse this route.

Please note that all dates are approximate and may vary due to weather and other factors out of our control which can affect the schedule. The best way for local motorists to stay informed is to check the Road Closings page on the BCEO web site at www.bceo.org/roadclosings. Emergency personnel, school bus transportation officials, the post office, and the media have been notified of this upcoming closure.
